As a result, the Company is delaying the filing of its Annual Report on Form 10-K for the fiscal year ended September 30, 2007 until it has completed the restatement process. The Company has also not yet filed its Quarterly Report on Form 10-Q for the quarter ended June 30, 2007. The Company is working expeditiously to complete the restatement process and file these reports as soon as practicable.
