Beazer Homes Appoints Division Presidents for Maryland and Virginia Divisions

Mr. Reeves graduated from Colgate University with a Bachelor of Arts in economics and received a Masters degree in public accounting from the University of Hartford. Mr. Reeves officially joined Beazer on October 1, 2012.
